# SAVE THE DATES! FALL 2016 WORKSHOPS

#### November 2, 2016 8:30 a.m. – noon Childhood Anxiety and OCD

*Presented by:* Muniya Khanna, Ph.D., Licensed Clinical Psychologist at the Children's and Adult Center for OCD

This workshop will provide an overview of CBT for treatment of pediatric anxiety disorders and OCD, cognitive-behavioral formulation of anxiety, treatment components, and the techniques to implement them. The parents' role in treatment and strategies to overcome barriers such as low motivation, comorbid conditions, and existing maladaptive patterns (i.e., parent-child conflicts, school refusal) will also be covered.

#### November 30, 2016 8:30 a.m. – noon Mandated Reporting of Child Abuse

*Presented by:* Mandy Mundy, Director of Education and Training, Network of Victim's Assistance

Although anyone can report suspected child abuse at any time, certain professionals, called "mandated reporters," are required by law to report suspected child abuse or maltreatment. Mandated reporters are of critical importance in the child abuse prevention effort. This workshop identifies the roles and responsibilities bystanders, care providers, and other professionals play in the prevention, protection, and intervention of child abuse.

#### November 30, 2016 1:00 – 4:00 p.m. Ethics Related to Maintaining and Releasing Records

Presented by: Allan M. Tepper, J.D., Psy.D., Renowned attorney/ psychologist

The topic of records continues to be a source of anxiety, if not angst, for many mental health professionals. The workshop will cover Pennsylvania law with regard to record keeping practices; retention periods; authorized release of records; mandated release of confidential information; and email communications with clients.

# 16 Students Join 2016 Summer Youth Corps

Sixteen college students from Bucks County have been chosen to participate in Foundations Community Partnership's 2016 Summer Youth Corps, which offers paid student internships at local non-profit human service agencies in Bucks County serving children, youth and families. The program provides students the ability to gain practical experience while helping to effect positive change in the community by working at non-profit human service agencies.

Interns are able to experience "service learning", a form of experiential education where students learn to solve community problems and achieve real objectives for the community while earning college credits. Service learning is a teaching and learning strategy that integrates meaningful community service with instruction and reflection to enrich the learning experience, teach civic responsibility, and strengthen communities. Service-learning is different from volunteerism in that it is a teaching and learning approach that integrates community service with academic study to enrich learning, teach civic responsibility, and strengthen communities.

"Our Summer Youth Corps combines community service with academic study," said Ron Bernstein, Executive Director of Foundations Community Partnership. "The program gives students the chance to gain college credits while participating in a meaningful work experience. Many of our Partnership in Education winners have been selected for the Summer Youth Corps so they can continue their community service work."

# Grantee Spotlight: Wheelz 2 Work – Bucks County Opportunity Council

Transportation can be a critical barrier to self-sufficiency for low-income families in Bucks County, which has few options for wide-spread public transportation. To bridge that gap, the Bucks County Opportunity Council is expanding its Wheelz 2 Work program, which accepts donated vehicles to provide to low-income families. BCOC accepts donations of vehicles in good working condition, ensures that they pass inspection and are road-safe, and then gifts the car to a family in their economic self-sufficiency program. The program goal is to serve 24 families over the next 12 months.
