Summer and Fall 2020 Grant Cycle Dates and Deadlines!

Partnership in Youth Services – (grant award: \$3,000) Application opened **July 1, 2020**, and closes **September 1, 2020**. *Note: PYS applications do not require an LOI before starting a full application*.

Bucks Innovation & Improvement (BIIG) – (grant award range: \$10,000–\$15,000) LOI process opened **July 1, 2020** and must be submitted no later than **October 1, 2020**. Following an LOI meeting with FCP, full applications due no later than **October 15, 2020**.

Capital Improvement – (grant award range: \$10,000–\$15,000) LOI process opened **July 1, 2020** and must be submitted no later than **October 1, 2020**. Following an LOI meeting with FCP, full applications due no later than **October 15, 2020**.


