#### SUMMER AND FALL GRANT CYCLE DATES AND DEADLINES!

#### Bucks Innovation & Improvement (BIIG) (Grant awards up to \$15,000)

LOIs are due no later than April 1, 2022. Following an LOI meeting with FCP, full applications are due no later than April 15, 2022.

#### Capital Improvement (Grant awards up to \$10,000)

LOIs are due no later than April 1, 2022. Following an LOI meeting with FCP, full applications are due no later than April 15, 2022.

#### Partnership in Youth Services (Grant award: \$3,000)

Application opens June 15, 2022, and closes August 15, 2022. *Note: PYS applications do not require a Letter of Inquiry (LOI) before starting a full application.* 

### **Tuition Assistance (Grant award varies depending on program)**

LOIs are due no later than July 15, 2022. Following an LOI meeting with FCP, full applications are due no later than August 1, 2022.

# FCP SUPPORTS HOME-GROWN LEADERSHIP FOR BUCKS COUNTY NON-PROFITS



FCP welcomed master's degree students and graduates from LaSalle's program to celebrate their accomplishments in spring of 2020.

Since 2015, FCP has assisted Bucks County non-profit organizations with succession planning and/or to strengthen the organization's management team. Organizations that received a grant from FCP within the past 5 years are eligible to complete a Tuition Assistance Grant application to support one staff member per grant cycle in either LaSalle University's Certificate in Nonprofit Management program or its Master of Science in Nonprofit Leadership degree program. Organizations establish their own criteria for and exercise complete control over the selection of the staff member from their organization to be supported by the Tuition Assistance Grant.

Nonprofits with an approved certificate candidate will be reimbursed equal to one-half (1/2) of the total tuition cost. The remaining cost will be funded by the organization and/or candidate. FCP will reimburse nonprofits that sponsor a certificate track student after five successfully completed courses and again after completion of the program. An approved master's degree candidate will be reimbursed equal to one-third (1/3) of the total tuition cost. The organization and the candidate are responsible for the remaining two-thirds (2/3) of the tuition.

## BUCKS NONPROFITS COLLABORATE TO LAUNCH THE "SERVING BUCKS TOGETHER" TRAINING CENTER

Habitat for Humanity Bucks County, Bucks County Opportunity Council, YWCA Bucks County, and Bucks County Housing Group formed an alliance to create the Serving Bucks Together Training Center (SBT), housed adjacent to Habitat's Restore in Warminster. FCP supported this initiative in Fall 2021 with a Capital Improvement Grant. The renovated space offers reliable, current technology capabilities to enable a streamlined, effective learning/meeting area

available to nonprofits needing such a space. Leaders of the allied nonprofits recognized that there is significant overlap in the constituents they serve, and that they can potentially serve more people, more efficiently, if they coordinated efforts in a shared space.

The allied nonprofits estimate that about 500 participants will benefit from activities hosted in the SBT, including internal and external training, employment and financial literacy workshops, racial and social justice programming, staff retreats, and occasional board meetings.

Chair of the Bucks County Commissioners Bob Harvie and State Senator Maria Collett joined non-profit leaders for the ribbon-cutting ceremony at the SBT.






### **BOARD OF DIRECTORS ANNOUNCES NEW APPOINTMENTS**
